

## Fall Tackle Your Finances 2017 Sweepstakes

### OFFICIAL RULES

No purchase, obligation or transaction necessary TO ENTER THE SWEEPSTAKES.

Promotion Period: Fall Tackle Your Finances 2017 ("Sweepstakes") begins October 1, 2017 and ends November 31, 2017. Entries received prior to or after the Promotion Period are not eligible for the Sweepstakes.

How to Enter: Individuals will receive an automatic entry into the Sweepstakes when they log into CFCU Community Credit Union between October 1, 2017 and ends November 31, 2017, and have added at least one spending target to their budget. One entry per household.

CFCU Community Credit Union (CFCU) and contest sponsor – Debtfolio, Inc. dba Geezeo – are not responsible for entries that are lost, misdirected, delayed, destroyed, deleted, erased, stolen, or unreadable. CFCU and Geezeo assume no responsibility for any error, problem, or malfunction (human, technical, or otherwise) which may occur in the creation, maintenance or processing of Sweepstakes entries, or which prevents entries from being created. Mail-in entries must be postmarked no later than November 31, 2017 and received by December 6, 2017. Proof of mailing does not constitute proof of delivery. The 3X5 card **MUST BE ENCLOSED IN A NEW STANDARD, BUSINESS SIZE ENVELOPE SIZED AT 4-1/8" x 9-1/2"**. A return address **MUST BE** on the envelope. Geezeo is not responsible for lost, late, incomplete, misdirected, damaged, postage-due, or illegible entries or mail. Mechanically reproduced entries will not be accepted. Alternate entries are limited to one per household and you MAY NOT send in multiple entrees for multiple financial institutions. Once submitted, all entries become the property of Geezeo and none will be returned.

Eligibility: Entries are open to the general public. No purchase necessary. To qualify for the Sweepstakes, entrants must be a resident of the 50 United States (D.C.), Guam and Puerto Rico and be 18 years or older.

Employees, Board members and consultants of CFCU Community Credit Union and its subsidiaries, and their family members within the same household are not eligible to win.

Sweepstakes subject to all applicable federal, state and local laws. Sweepstakes void where prohibited or restricted by law.

Agreement to Official RULES: **Participation in the Sweepstakes constitutes entrant's full** and unconditional agreement to and acceptance of these Official Rules and the decisions of Geezeo, which are final and binding in all matters relating to this Sweepstakes.

Selection of Winners: Winners will be chosen by random selection the week of December 9th, 2017, from all eligible entries received during the Promotion Period from all participating financial institutions. There will be a total of five (5) prizes: \$250.00 grand prize, \$250.00 first runner up prize, \$100.00 second runner up prize, \$100.00 third runner prize, and \$100.00 fourth runner up prize.

For a selected entry to be declared a winner, the winning individual must satisfy all of the requirements as listed in these Official Rules. Winners need not be present and will be notified by e-mail, mail or telephone within 5 business days of selection. If a winning individual does not affirmatively accept his or her prize in writing or via e-mail within 10 calendar days of notification, an alternate entrant will be selected at random in his or her place from all eligible entries received.

Prize winners will be required to sign an affidavit of eligibility and liability/publicity release which must be returned within 10 days of notification. Winners agree to permit Geezeo and CFCU Community Credit Union to use their name, likeness, and city of residence for advertising and promotional purposes without additional compensation except where prohibited by law. Geezeo and CFCU Community Credit Union will make its best reasonable effort to contact all winners. If any winner cannot be contacted, an alternate winner will be randomly selected.

Prizes: There will be awarded five (5) prizes: \$250.00 Grand Prize, \$250.00 first runner up prize, \$100.00 second runner up prize, \$100.00 third runner prize, and \$100.00 fourth runner up prize. The arrangement of the prize distribution will be handled between the Prize Winner

and Geezeo/CFCU Community Credit Union. Geezeo/CFCU Community Credit Union does not guarantee any specific rates or stock availability. No prize substitution is allowed.

The odds of winning are approximately 1 in 30,000; however, actual odds of winning will depend upon the number of entries received from all participating financial institutions.

Final determination of winners will be made by a staff member of Geezeo, whose decision is final.

Prizes are non-transferable and no substitution of prizes is permitted without the permission of Geezeo, which reserves the right to substitute a prize with another prize of equal or greater value. Geezeo will report all prize winnings to the appropriate state and federal agencies as required by applicable law. If that cannot be done, you and we agree that any dispute arising out of or connected with this Contest will be resolved by BINDING ARBITRATION administered by the American Arbitration Association in accordance with its Commercial Dispute Resolution Procedures and Supplementary Procedures for Consumer-Related Disputes. Your rights will be determined by a NEUTRAL ARBITRATOR and NOT a judge or jury. Arbitrator decisions are as enforceable as any court order and are subject to VERY LIMITED REVIEW BY A COURT. The place of arbitration shall be in the County in which you reside.
